



Schematic




A 0.1 μF bypass capacitor must be connected between pin 8 and 5.






Test Circuit 1: IOPH




Test Circuit 2: IOPL




Test Circuit 3: VOH




Test Circuit 5: ICCH




Test Circuit 4: VoL




Test Circuit 6: ICCL



Test Circuit 7: t_{pLH}, t_{pHL}, t_r, t_f, PDD




